# Are you the descendant of an American railroad worker?

Membership is eligible to all people who can prove lineal descent from a railroad worker who served between March 4, 1825 and December 31, 1945.

A "railroad worker" is defined as an individual who contributed to the building, maintenance, or administration of a railroad, commuter rail, or a street car system in the U.S., Mexico, or Canada. The qualifying ancestor does not have to be directly employed by a railroad company as long as there is proof of his/her contributions.

Acceptable service includes, but is not limited to:

- Baggage handlers/masters
- Brakemen
- Conductors
- Engineers
- Engine watchmen
- Express agents
- Firemen (who worked on board or in the railyards)
- Flagmen
- Hostlers
- Porters
- Railroad administration (officers, attorneys, accounting, etc. if employed by the railroad
- Railroad laborers (as designated in the U.S. census)
- Railway mail clerks/agents (even if the U.S. Postal Service was their official employer)
- Section crew/gang
- Station agents
- Switchmen
- Telegraphers (employed by the railroad)
- Ticket agents
- Urban rail (including streetcars, subways and commuter rail, but not buses)
- Wipers
